LOCAL LAW NO. 2 OF 1966.

A LOCAL LAW PROVIDING FOR A UNIFORM CLOTHING ALLOWANCE FOR MEMBERS OF THE FIRE DEPARTMENT OF THE CITY OF PLATTSBURGH, FOR THE YEAR 1966.

BE IT ENACTED, by the Common Council of the City of Plattsburgh, New York, as follows:

SECTION 1. Pursuant to the Provisions of the Municipal Home Rule Law and the General City Law of the State of New York, the City of Plattsburgh is hereby authorized and empowered to reimburse permanent members of the Plattsburgh Fire Department for approved uniforms in an amount not to exceed One Hundred (\$100.00) Dollars for the year 1966 for each permanent member, upon presentation to the City Chamberlain of vouchers, together with receipted bills showing the expenditure of the same. All said vouchers and reimbursements to be made in the same manner as other City bills are paid.

SECTION 2. The following are approved Fire Department clothing for which reimbursement shall be made:

1. CAPS. Caps of a standard approved type, flat cap, Navy blue for firemen. Same type with black band for rank above Lieutenant. Caps worn by officers will have a gold band around the brim. Firemen will have a plain black leather band. This cap to be worn for all occasions.
2. SHOES. Plain black leather uniform shoes will be worn as standard equipment with all uniforms. Low shoes may be worn with the summer uniform and blouse.

3. INSIGNIA OF RANK:

Chief of Fire Department----- 5 gold horns
Acting Chief----- 4 gold horns
Lieutenants----- 1 gold horn

4. SERVICE INSIGNIA: One gold star for each 5 years of service to be worn on the lower left sleeve.

5. TIES: Black cloth - four in hand, either regular or ready tied.

6. SOCKS: Black, dark blue or white.

7. SHIRTS: OFFICERS - BLUE WOOL, Serge or tropical worsted, shoulder straps, two patch pockets, to be worn going back and forth to work.

- WHITE shirt to be worn for parades, funerals and all other social events. Class A.

FIREMEN - BLUE denim shirt, shoulder straps, two patch pockets, to be worn going back and forth to work.

- WHITE shirt to be worn for parades, funerals and all other social events.

PLAIN BLUE DENIM shirts to be worn as a work uniform.

OPTIONAL - Office staff may wear white uniform shirts at any time.

8. TROUSERS: CLASS B. - Officers and men will wear dark navy wool trousers, zipper fly, with no cuffs.

CLASS C. - Officers will wear dark navy trousers at all times.
Firemen will wear dungaree trousers.

9. BLOUSE: CLASS A. - Semi-fitted, tailor made, wool serge for both officers and firemen.

Officers - gold buttons on blouse
Firemen - silver buttons on blouse

10. COAT: CLASS B. - Tanker coat, blue, zipper front.

11. SHOULDER PATCHES: All outer garments will bear the accepted Fire Department shoulder patch.

12. NAME PLATES: White letters on blue background, plastic, to be worn over right breast of outer garment.

13. PANTS BELT: Black leather 1½" wide.


SECTION 3. This act shall take effect after a public hearing and approval by the Mayor.
