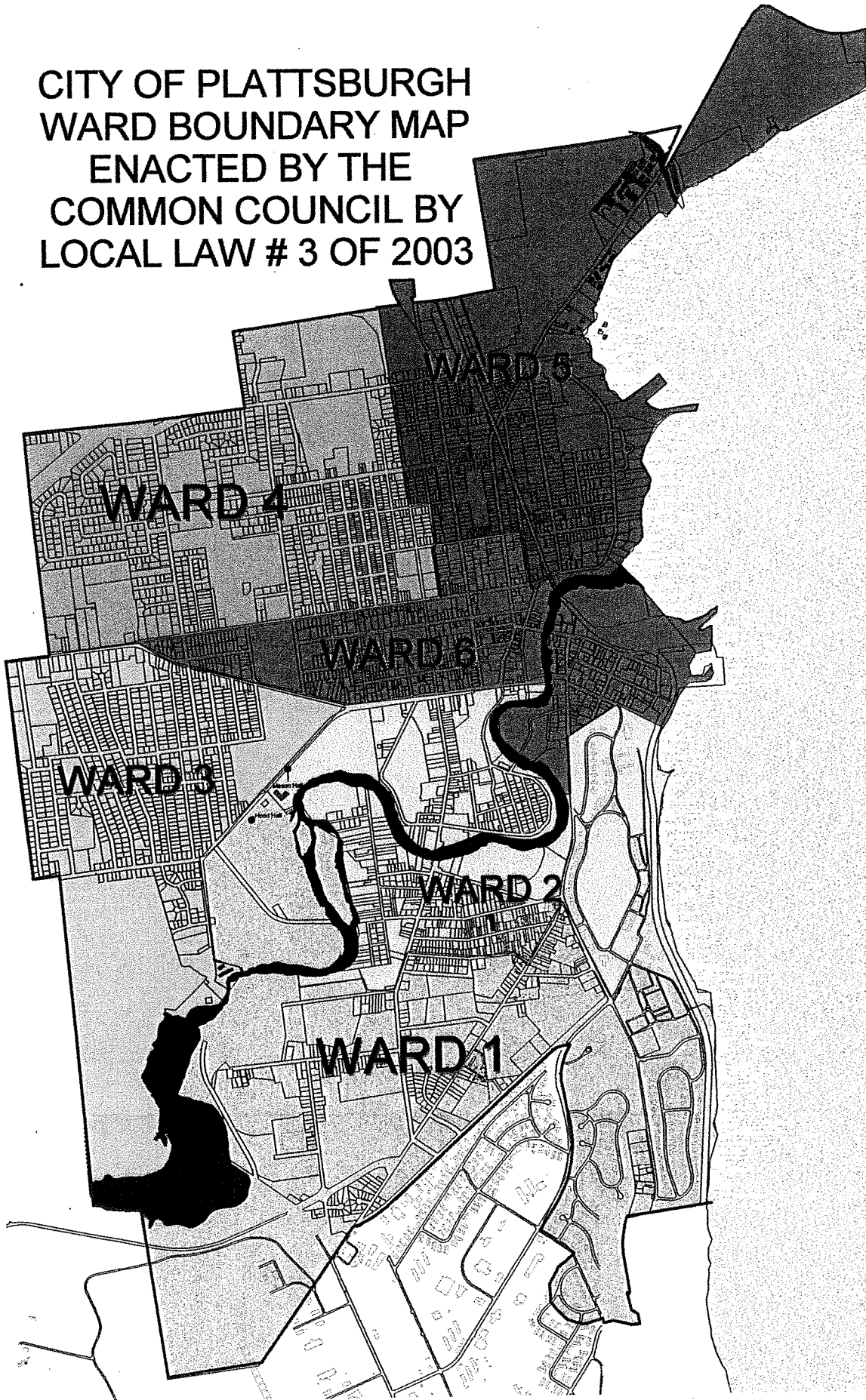

1. Section C1-4 A of the City Code is amended in its entirety to read as follows:
  - (a) (a) C1-4 A (1) The City shall be divided into six (6) wards numbered consecutively one through six.
  - (b) (b) C1-4 A (2) The wards shall be divided into one or more election districts in accordance with the New York State Election Law.
  - (c) (c) The ward boundaries shall be as set forth on the annexed map entitled "City of Plattsburgh Ward Boundary Map Enacted by Local Law 3 of 2003" which is hereby made an appendix to Article I of the City Charter.
2. On or before April 1, 2003 the Corporation Counsel shall prepare a description of the ward boundaries and sign and certify same as accurately describing the boundaries depicted on the map.
3. A copy of this local law together with the annexed map and the ward boundary description shall be filed with the City Clerk and the Clinton County Board of Elections.
4. This local law shall take effect on April 1, 2003, after approval by the Mayor and filing with the Secretary of State.
