

WHEREAS, the following resolution was adopted on February 13th, 2020, and

WHEREAS, the Capital Expenditure Plan adopted December 12th, 2019, includes a Public Service Equipment category, and

WHEREAS, the Infrastructure Division desires to establish a 2020 Equipment Purchase project for items included in the Public Service Equipment category of the Capital Expenditure Plan adopted December 12th, 2019, and

WHEREAS, the cost of the 2020 Equipment Purchase project has been estimated by the Infrastructure Division for the costs of the planned expenditures as noted below to purchase items included in the expenditure plan for 2020, as follows:

- 1) That, the amount of Five Hundred Ten Thousand and 00/100 (\$510,000.00) Dollars is hereby appropriated for the capital project **2020 Equipment Purchase (H5110.74)** for the cost of the equipment listed above and is hereby authorized to be expended for such purpose.
- 2) That, Fifty Thousand and 00/100 (\$50,000.00) Dollars of such appropriation be provided by the Water Fund.
- 3) That, Fifty Thousand and 00/100 (\$50,000.00) Dollars of such appropriation be provided by the Sewer Fund.
- 4) That, Four Hundred Ten Thousand and 00/100 (\$410,000.00) Dollars of such appropriation will be provided by an advance from the General Fund, but that such advance is to be repaid to the General Fund by year end through funding of this portion of the project with Bond Anticipation Notes or Serial Bonding.
- 5) That, this resolution takes effect immediately.


