1. Pursuant to section 1262 (d) of the Tax Law of the State of New York, Article V of Chapter 240 of the Code of the City of Plattsburgh be and hereby is repealed.

2. Pursuant to section 1262 (c) of the Tax Law of the State of New York, the City of Plattsburgh hereby elects to receive direct payment of the amount of the County sales tax allocated to the City of Plattsburgh in lieu of having such amount applied to reduce the county tax levied upon real property within the City.

3. Pursuant to section 1262 (c) of the Tax Law of the State of New York, the Budget Committee of the Common Council of the City of Plattsburgh is authorized to negotiate an agreement for the allocation of County sales tax revenues to the City of Plattsburgh, provided that any such agreement shall be subject to approval by the Common Council as a whole.

4. The City Clerk is directed to mail a copy of this local law to the County Treasurer and the State Tax Commission by registered mail prior to September 1, 1992.

5. This local law shall take effect on March 1, 1993.


