The project includes, but is not limited to, providing: installation and replacement of panels, wiring, fused disconnects, equipment disconnects, motor starters, and circuitry in and around the 1936 Filter Building and the 1956 Filter Building; new branch circuitry, starters, and motors for the existing flocculation and settling basins; installation approximately 190-LF of new yard conduit connecting the existing emergency generator to a replacement garage panel and subpanel including trenching and installation of new ductbank; the demolition of existing conduit, wiring, panels, fused disconnects, equipment disconnects, motor starters, and circuitry in and around all buildings.
