## LOCAL LAW NO. 1 OF 1933.

ENTITIED AN ACT to amend Section 11 of the City Charter of the City of Plattsburgh, New York, being part of Chapter 269 of the Laws of 1902 of the State of New York, as amended by Local Law No. 2 of 1924, Local Law No. 1 of 1925, Local Law No. 2 of 1925, Local Law No. 2 of 1926, Local Law No. 2 of 1927, Local Law No. 3 of 1927 and Local Law No. 2 of 1930, providing in this instance for the fixing of the salary of the Commissioner of Public Welfare.

BE IT ENACTED by the Mayor and Common Council of the City of Plattsburgh, N.Y., that the provisions of Section 11 of the City Charter of the City of Plattsburgh, N.Y., as amended by the foregoing mentioned local laws and with reference to the salaries of the city officials mentioned therein that the following shall replace the provisions thereof in relation to the salary of the Commissioner of Public Welfare of the City of Plattsburgh, N.Y., which shall be Sixteen Hundred Dollars per annum beginning Jan-uary 7, 1933, Eight Hundred Dollars of which shall be charged against the Public Welfare Fund and Eight Hundred Dollars of which shall be charged against the Old Age Relief Fund, in the which shall be charged against the Old Age Relief Fund, in the which shall be charged against the Old Age Relief Fund, in the in part by the State of New York, as provided by Section 124-d of Article XIV-A of the Public Welfare Law, it being understood, as provided by Local Law No. 9 of 1932, that the Commissioner of Public Welfare is to attend to the investigation of all applications for old age relief within the public welfare district of the City of Plattsburgh, N.Y. and to determine to whom such old age relief shall be given or granted with due regard to the condition existing in each case and such other provisions as are prescribed therein dealing with the administration of the requirements of the Article above-mentioned.

BE IT FURTHER ENACTED, That Section 11 of the City Charter as hereby amended and as amended by later legislative acts and local laws not inconsistent herewith shall remain in full force and effect.

On roll call Aldermen Holland, Roach, Raymond, Light, Spearman and Shay voted in the affirmative. No one in the negative.
