

REGULAR MEETING of the Common Council of the City of Plattsburgh, New York, held January 15th, 1943.

PRESENT: Mayor Bouyea, Aldermen Holland, O'Connell, Giolosa, Demary, Behan and Tyrell.

By Alderman Behan; seconded by Alderman Tyrell:

LOCAL LAW NO. 1 of 1943.

ENTITLED AN ACT to amend Section 11 of Chapter 269 of the Laws of 1902, as amended by Local Law No. 2 of 1924, Local Law No. 1 of 1925, Local Law No. 2 of 1925, Local Law No. 2 of 1926, Local Law No. 2 of 1927, Local Law No. 3 of 1927, Local Law No. 2 of 1930, Local Law No. 1 of 1933, Local Law No. 4 of 1939, Local Law No. 5 of 1939, Local Law No. 7 of 1939, and Local Law No. 1 of 1942, providing in this instance for a salary for each Member of the Municipal Civil Service Commission, to be fixed at \$600.00 per annum, and for an increase in the salary of each Member of the Board of Assessors, \$100.00 per annum.

BE IT ENACTED by the Mayor and Common Council of the City of Plattsburgh, New York, that Section 11 of Chapter 269 of the Laws of 1902, as amended by the aforementioned Local Laws, and other Local Laws approved and adopted subsequent thereto, be and the same is hereby further amended, and as so amended to be superseded by the following:

SECTION 11. The compensation of city officers: Members of the Board of Education, except the Clerk, Members of the Board of Health, Members of the Park and Beach Commission, and Members of the Planning Board shall receive no compensation for their services.

The annual salary of the Mayor shall be \$1800.00, \$1200.00 of which shall be payable out of the General Fund and \$600.00 shall be payable out of the Water Fund.

The Aldermen shall receive \$5.00 for each meeting of the Common Council actually attended, but not in excess of \$250.00 each year, payable out of the General Fund.

The annual salary of the City Judge shall be \$1800.00 payable out of the Police Fund.

The annual salary of the City Clerk shall be \$3300.00, of which amount \$1350.00 shall be payable out of the General Fund, \$1350.00 shall be payable out of the Water Fund, \$300.00 shall be payable by the Municipal Lighting Department, and \$300.00 shall be payable out of the Sewer Operation and Maintenance Fund. That in addition to the duties now imposed upon the City Clerk, the said City Clerk shall also be Custodian of the City Hall and shall have supervision of the Janitor and Assistant Janitors.

The annual salary of the Deputy City Clerk shall be \$2200.00, of which sum \$800.00 shall be payable out of the General Fund, and \$1400.00 shall be payable out of the Water Fund, or Water Revenues.

The annual salary of the Commissioner of Public Welfare shall be \$2300.00, \$1150.00 of which shall be payable out of the Public Welfare Fund and \$1150.00 of which shall be payable out of the Old Age Assistance Fund.

The annual salary of the Public Health Officer shall be \$1500.00, \$1200.00 of which shall be payable out of the Board of Health Fund and \$300.00 of which shall be payable out of the Public Welfare Fund.

The annual salary of each Assessor shall be \$300.00, excepting that the salary of the Chairman of the Board shall be \$400.00 per annum, payable out of the General Fund.

The annual salary of the Corporation Counsel shall be \$2,000.00, \$600.00 of which shall be payable out of the Water Fund, \$300.00 of which shall be payable out of the Sewer Operation & Maintenance Fund, \$950.00 of which shall be payable out of the General Fund, and \$150.00 of which shall be payable out of the Municipal Lighting Fund.

The annual salary of the Sealer of Weights & Measures shall be \$330.00, payable out of the General Fund.

The annual salary of the Superintendent of Public Works shall be \$3300.00, \$1375.00 of which shall be payable out of the Water Fund, \$1375.00 of which shall be payable out of the Street & Sewer Fund, \$150.00 of which shall be payable out of the Municipal Lighting Fund, and \$400.00 of which shall be payable out of the Sewer Operation & Maintenance Fund. The Superintendent of Public Works shall also be Superintendent of Parks, of the Water System, and of the Municipal Bathing Beach.

The salary of the Chief, or Acting Chief of Police, shall be \$2560.00 per annum, payable out of the Police Fund.

The salary of each of the Sergeants of Police shall be \$1860.00 per annum, payable out of the Police Fund.

The annual salary of each of the Regular Patrolmen on appointment shall be \$1600.00, with an increase of \$100.00 after the first year and \$100.00 after the second year. That the salary of the Patrolmen after having served two years shall be \$1800.00 per annum, all of which shall be payable out of the Police Fund.

The annual salary of the City Chamberlain shall be \$1700.00, \$850.00 of which shall be payable out of the General Fund and \$850.00 shall be payable out of the Water Fund.

The Supervisors and Constables shall be entitled to the same compensation for their services as corresponding Officers in the Towns are entitled to receive for like services.

The Inspectors of Election and such other Election Officers as are authorized to be appointed, shall receive such compensation as shall be fixed by the Common Council.

The annual salary of the Chief Engineer of the Fire Department shall be \$2100.00, payable from the Fire Fund.

The annual salary of the Assistant Chief Engineer of the Fire Department shall be \$1860.00, payable from the Fire Fund.

The annual salary of each Regular Fireman on appointment shall be \$1600.00 for the first year, and the same shall be increased at the rate of \$100.00 per year until each Regular Fireman shall receive the sum of \$1800.00 per year. Each and every member of the Fire Department who shall have served more than two years at the time of the enactment of this Local Law shall be entitled to the maximum pay provided for herein, and each member who has served less than two years at the time of the enactment of this Local Law shall be entitled to the pay provided for in this Act, according to the term of his service; these same provisions shall apply to the Members of the Police Department.

The annual salary of each member of the Municipal Civil Service Commission shall be \$600.00 per year, payable out of the General Fund, for which an amount equal to the salaries herein authorized to be paid shall be included therein and appropriated in the General City Budget to become effective January 1st, 1943.


The salaried Officers by the year or month shall be paid semi-monthly for actual services.

No other appointive Officer of the City shall be entitled to receive from the City any compensation for his services, unless otherwise provided by this Act, or by General Law or Local Law.

The foregoing Local Law shall take effect January 1st, 1943, and after public hearing and approval by the Mayor.

On roll call, Aldermen Holland, O'Connell, Gioiosa, Demary, Behan and Tyrell voted in the affirmative; no one in the negative,
