LOCAL LAW NO. 1 of 1989

A LOCAL LAW PROVIDING RATES AND REGULATIONS FOR WATER
SERVICES AND PROVIDING PROCEDURES FOR THE LEVYING AND
COLLECTION OF WATER CHARGES.

BE IT ENACTED by the Mayor and Common Council of the
City of Plattsburgh, New York as follows:

Section 1: The following rates and regulations for
water services and the method of collection of levying of
water charges is hereby enacted.

APPLICABLE TO THE USE OF SERVICE FOR:

All customers taking service within the corporate limits of the City of Plattsburgh, from June 15, 1989 to December 31, 1989.

Continous.

TERMS OF PAYMENT:

Except as shown under "Special Provisions" below, meters are read and bills are rendered once every three months in arrears. The net amount is due when bill is rendered. Gross amount shall be due after date shown on bill.

TERM:

From the date of commencement of service, pursuant to application, until 10 days written notice is given prior to the date set for discontinuance or upon discontinuance by the water department in accordance with the provisions of this Schedule for Water Service.

SPECIAL PROVISION:

Meters may be read and/or bills rendered monthly at the option of the Water Department. Where bills are rendered on a monthly basis, one-third of the above quantities will be used in computing the charges for the various steps. The terms of payment, for monthly billings are net-fifteen days after date of bill. Gross amount shall be due thereafter.

All those customers who do not have water meters installed in the water service line serving their premises on the effective date of this service classification shall be billed at the rate of \$17.99 per quarter to January 1, 1990 and \$19.79 per quarter thereafter until such time that a water meter has been set in the water service line to their premises. Thereafter, the rates for water service above set forth shall apply.

Elderly persons that qualify for the Real Property Tax Exemption shall also be exempt from the Minimum Charge for water service and be charged for only the actual gallons of water consumed.

All customers taking service outside the corporate limits of the City of Plattsburgh, from June 15, 1989 to December 31, 1989.

Except as shown under "Special Provisions" below, meters are read and bills are rendered once every three months in arrears. The net amount is due when bill is rendered. Gross amount shall be due after date shown on bill.

TERMS:

From the date of commencement of service, pursuant to application, until 10 days written notice is given prior to the date set for discontinuance or upon discontinuance by the Water Department in accordance with the provisions of this Schedule for Water Service.

SPECIAL PROVISION:

Meters may be read and/or bills rendered monthly at the option of the Water Department. Where bills are rendered on a monthly basis, one-third of the above quantities will be used in computing the charges for the various steps. The terms of payment, for monthly billings are net-fifteen days after date of bill. Gross amount shall be due thereafter.

All those customers who do not have water meters installed in the water service line serving their premises on the effective date of this service classification shall be billed at the rate of \$35.98 per quarter to January 1, 1990 and \$39.57 per quarter thereafter until such time that a water meter has been set in the water service line to their premises. Thereafter, the rates for water service above set forth shall apply.

Private fire protection service within the corporate limits of the City of Plattsburgh.

None.

TERMS OF PAYMENT:

Net cash on presentation of bill. Bills may be rendered quarterly or monthly.

TERMS:

From the date of commencement of service, pursuant to application, until thirty days written notice is given prior to the date set for discontinuance by the Water Department in accordance with provisions of this Schedule Water Service.

SPECIAL PROVISION:

The foregoing rates for private fire protection service are based on unmetered service. Water for Fire Extinguishment purposes and limited testing requirements is provided at no extra charge. However, if, in the opinion of the Water Department, the installation of a fire line meter is required, the customer shall make said installation at his own expense. The entire meter installation shall be constructed and installed according to the specifications of the Water Department. There shall be no branch connections to said fire service line other than those for fire protection service.

SECTION 2: LAWS REPEALED

All acts pertaining to water rates and regulations and all other schedules of water rates and regulations heretofore adopted and inconsistent in whole or in part with this act is hereby repealed.

SECTION #: TIME OF TAKING EFFECT

This act shall take effect for water bills rendered on and after June 15, 1989.
