AT A REGULAR MEETING OF THE COMMON COUNCIL OF THE CITY OF PLATTSBURGH, NEW YORK, HELD APRIL 1, 1965.

PRESENT: MAYOR TYRELL, ALDERMEN BOOTH, BEAUVAIS, DUKEN, SABOURIN, BRANON & FLYNN.

LOCAL LAW NO. 3 OF 1965

ENTITLED A LOCAL LAW TO PROVIDE HEALTH INSURANCE PROTECTION FOR REGULAR CITY OFFICIALS, DEPARTMENT HEADS, EMPLOYEES, RETIRED EMPLOYEES AND THEIR FAMILIES.

BE IT ENACTED BY THE MAYOR AND COMMON COUNCIL OF THE CITY OF PLATTSBURGH, NEW YORK, AS FOLLOWS:

SECTION 1. THAT THE CITY OF PLATTSBURGH, PURSUANT TO AUTHORITY PROVIDED IN SECTION 92-A OF THE GENERAL MUNICIPAL LAW, SHALL PAY THE PREMIUMS FOR NEW YORK STATE HEALTH INSURANCE STATEWIDE PLAN, FOR REGULAR CITY OFFICIALS, DEPARTMENT HEADS, EMPLOYEES AND RETIRED EMPLOYEES, AND MEMBERS OF THEIR FAMILIES, EFFECTIVE ON AND AFTER MAY 1, 1965.

SECTION 2. THAT THE NEW YORK STATE HEALTH INSURANCE PROGRAM "MANUAL OF PROCEDURES FOR PARTICIPATING SUBDIVISIONS" SHALL BE THE GUIDE IN ADMINISTERING THIS PLAN BY THE CITY OF PLATTSBURGH, N.Y.

SECTION 3. THAT EMPLOYEES WITH DEPENDENT STUDENTS, AS DEFINED IN THE MANUAL OF PROCEDURES, SHALL BE EXTENDED THE PRIVILEGES OF DEPENDENT STUDENT COVERAGE AS PROVIDED FOR IN THE NEW YORK STATE HEALTH INSURANCE PLAN UPON PAYMENT DIRECT TO THE CITY CHAMBERLAIN'S OFFICE OF THE NECESSARY PREMIUM. THESE PAYMENTS SHALL BE BY THE CALENDAR QUARTER IN ADVANCE.

SECTION 4. HEALTH INSURANCE COVERAGE FOR RETIRED EMPLOYEES.

A. HEALTH INSURANCE COVERAGE OF EMPLOYEES RETIRED PRIOR TO MAY 1, 1965, WILL BE PROVIDED FOR UNDER COVERAGES IN EFFECT FOR THESE EMPLOYEES PRIOR TO MAY 1, 1965.

B. HEALTH INSURANCE COVERAGE FOR EMPLOYEES RETIRED ON AND AFTER MAY 1, 1965, WITH AN AGGREGATE OF TWENTY YEARS OR MORE OF PAID CITY SERVICE, THE CITY OF PLATTSBURGH SHALL PAY THE PREMIUM FOR SUCH INSURANCES, BUT SUCH PAYMENTS WILL CEASE UPON THE RETIRED PERSON'S DEATH.

C. THAT CITY EMPLOYEES WITH AN AGGREGATE OF AT LEAST FIFTEEN YEARS OF SERVICE AND RETIRED ON A DISABILITY, SHALL BE PROVIDED FOR AS IN "B" ABOVE.

D. THAT OTHER RETIRED EMPLOYEES WILL BE PROVIDED HEALTH INSURANCE COVERAGE AS PROVIDED FOR IN THE NEW YORK STATE HEALTH INSURANCE PLAN.

SECTION 5. THAT FOR THE PURPOSES OF ADMINISTERING THE NEW YORK STATE HEALTH INSURANCE PLAN AS DEFINED IN THE "MANUAL OF PROCEDURES FOR PARTICIPATING SUBDIVISIONS" THE CITY CHAMBERLAIN'S OFFICE IS DESIGNATED THE PERSONNEL OFFICE OF THE CITY OF PLATTSBURGH.

SECTION 6. TIME OF TAKING EFFECT.

THIS ACT SHALL BE IN EFFECT ON AND AFTER MAY 1, 1965, AFTER PUBLIC HEARING AND APPROVAL BY THE MAYOR.
