1. Sections 2.1, 2.2 and 2.3 of Local Law No. 3 of 1997 is hereby amended to increase the maximum exemption permitted under RPTL 458-a2 as follows:

- .1 Under section 2.1 from 12,000 dollars to 27,000 dollars
- .2 Under section 2.2 from 8,000 dollars to 18,000 dollars
- .3 under section 2.3 from 40,000 dollars to 90,000 dollars

2. This local law shall take effect with the 2003 real property tax roll.

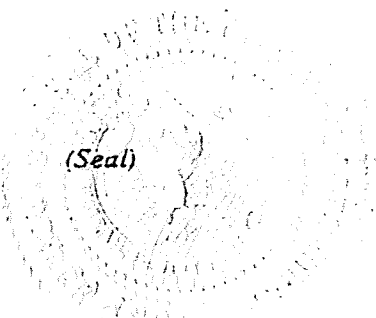
