LOCAL LAW NO. 4 OF 1957.

ENTITLED A LOCAL LAW AMENDING SECTION 119 OF THE ADMINISTRATIVE
CODE OF THE CITY OF PLATTSBURGH, NEW YORK.

BE IT ENACTED BY THE COMMON COUNCIL OF THE CITY OF PLATTSBURGH, N. Y.

SECTION I: SECTION 119 OF THE ADMINISTRATIVE CODE IS HEREBY AMENDED
TO READ AS FOLLOWS:


SECTION 119: UNNECESSARY SMOKE AND SOOT PROHIBITED. THE EMISSION OF
SMOKE OF SUCH DENSITY AND VOLUME AS TO DARKEN AND BEFOUL THE AIR AND DEPOSIT
SOOT ON ADJACENT PROPERTY, BY USE OF BITUMINOUS OR SEMI-BITUMINOUS COAL,
WITHOUT THE INSTALLATION OF A SUITABLE SMOKE CONSUMER OR OTHER MECHANICAL
MEANS OF ABATEMENT, WHETHER THE EMISSION BE CONTINUOUS OR DURING THE PROCESS
OF STOKING IS PROHIBITED WITHIN THE CITY LIMITS. THE USE OR BURNING OF ANY
AND ALL REFUSE, SUCH AS RUBBER, WASTE OR REFUSE OIL OR WASTE FROM AUTOMOTIVE
MOTORS, HAIR, LEATHER, GARBAGE, WASTE BUILDING MATERIALS FOR ANY PURPOSE
WHATSOEVER IS HEREBY PROHIBITED.

SECTION II. THIS ACT SHALL TAKE EFFECT AFTER PUBLIC HEARING AND
APPROVAL BY THE MAYOR.


ON ROLL CALL, ALDERMEN HOLLAND, BRAULT, DAME, JABAUT, CORODIMAS AND
