LOCAL LAW NO. 4 OF 1976

A LOCAL LAW PROVIDING RATES AND REGULATIONS FOR THE USE  
OF PUBLIC AND PRIVATE SEWERS AND DRAINS AND FOR THE  
LEVYING AND COLLECTION OF SEWER CHARGES:

BE IT ENACTED by the Mayor and Common Council of the  
City of Plattsburgh, New York as follows:

SECTION 1: The following are the rates and regulations  
for sewer services in the City of Plattsburgh.

SERVICE CLASSIFICATION NO. ....<sup>1</sup>.....

APPLICABLE TO THE USE OF SERVICE FOR:

ALL CUSTOMERS TAKING SERVICE WITHIN THE CORPORATE LIMITS  
OF THE CITY OF PLATTSBURGH.

CHARACTER OF SERVICE:

CONTINUOUS.

RATE:

PER QUARTER, BASED ON METERED WATER CONSUMPTION.

TERMS OF PAYMENT:

EXCEPT AS SHOWN UNDER "SPECIAL PROVISIONS" BELOW, METERS ARE READ AND BILLS ARE RENDERED ONCE EVERY THREE MONTHS IN ARREARS. THE NET AMOUNT IS DUE WHEN BILL IS RENDERED. GROSS AMOUNT SHALL BE DUE AFTER DATE SHOWN ON BILL.

TERM:

FROM THE DATE OF COMMENCEMENT OF SERVICE, PURSUANT TO APPLICATION, UNTIL 10 DAYS WRITTEN NOTICE IS GIVEN PRIOR TO THE DATE SET FOR DISCONTINUANCE OR UPON DISCONTINUANCE BY THE SEWER DEPARTMENT IN ACCORDANCE WITH THE PROVISIONS OF THIS SCHEDULE FOR SEWER SERVICE.

SPECIAL PROVISIONS:

ALL THOSE CUSTOMERS WHO DO NOT HAVE WATER METERS INSTALLED IN THE WATER SERVICE LINE SERVING THEIR PREMISES ON THE EFFECTIVE DATE OF THIS SERVICE CLASSIFICATION SHALL BE BILLED AT THE RATE OF \$30.00 PER QUARTER UNTIL SUCH TIME THAT A WATER METER HAS BEEN SET IN THE WATER SERVICE LINE TO THEIR PREMISES. THEREAFTER, THE RATES FOR SEWER SERVICE ABOVE SET FORTH SHALL APPLY.

BILLS MAY BE RENDERED MONTHLY AT THE OPTION OF THE SEWER DEPARTMENT. WHERE BILLS ARE RENDERED ON A MONTHLY BASIS, ONE-THIRD OF THE ABOVE QUANTITIES WILL BE USED IN COMPUTING THE CHARGES FOR THE VARIOUS STEPS. THE TERMS OF PAYMENT, FOR MONTHLY BILLINGS ARE NET-FIFTEEN DAYS AFTER DATE OF BILL. GROSS AMOUNT SHALL BE DUE THEREAFTER.

SERVICE CLASSIFICATION NO. 2 .....

APPLICABLE TO THE USE OF SERVICE FOR:

ALL CUSTOMERS TAKING METERED WATER SERVICE OUTSIDE THE CORPORATE LIMITS OF THE CITY OF PLATTSBURGH.

CHARACTER OF SERVICE:

CONTINUOUS.

RATE:

PER QUARTER, BASED ON METERED WATER CONSUMPTION.

TERMS OF PAYMENT:

EXCEPT AS SHOWN UNDER "SPECIAL PROVISIONS" BELOW, METERS ARE READ AND BILLS ARE RENDERED ONCE EVERY THREE MONTHS IN ARREARS. THE NET AMOUNT IS DUE WHEN BILL IS RENDERED. GROSS AMOUNT SHALL BE DUE AFTER DATE SHOWN ON BILL.

TERM:

FROM THE DATE OF COMMENCEMENT OF SERVICE, PURSUANT TO APPLICATION, UNTIL 10 DAYS WRITTEN NOTICE IS GIVEN PRIOR TO THE DATE SET FOR DISCONTINUANCE OR UPON DISCONTINUANCE BY THE SEWER DEPARTMENT IN ACCORDANCE WITH THE PROVISIONS OF THIS SCHEDULE FOR SEWER SERVICE.

SPECIAL PROVISIONS:

ALL THOSE CUSTOMERS, PRESENTLY FURNISHED WATER SERVICE BY A WATER DISTRICT, WHICH ITSELF IS A WATER CUSTOMER OF THE CITY OF PLATTSBURGH, AND WHO ARE CONNECTED TO THE SEWER SYSTEM OF THE CITY, SHALL BE BILLED FOR SAID SEWER SERVICE AT THE RATE OF \$67.50 PER QUARTER.

BILLS MAY BE RENDERED MONTHLY AT THE OPTION OF THE SEWER DEPARTMENT. WHERE BILLS ARE RENDERED ON A MONTHLY BASIS, ONE-THIRD OF THE ABOVE QUANTITIES WILL BE USED IN COMPUTING THE CHARGES FOR THE VARIOUS STEPS. THE TERMS OF PAYMENT, FOR MONTHLY BILLINGS ARE NET-FIFTEEN DAYS AFTER DATE OF BILL. GROSS AMOUNT SHALL BE DUE THEREAFTER.

SECTION 2: Laws Repealed.

All schedules of sewer rates and regulations heretofore enacted and inconsistent in whole or in part with this local law are hereby repealed.

SECTION 3: Time of Taking Effect.

This Local Law shall take effect for sewer services rendered on and after September 1, 1976.


On roll call, Aldermen Burke, Stewart, Haley, Blumette, Griffin and Poitras voted in the affirmative; no one in the negative;
