- 1. The term "property" means land, buildings, or space within buildings. The term "rent" includes consideration paid for a license.
- 2. The Common Council is authorized and empowered to lease or grant a license for the use of property owned by the City of Plattsburgh in accordance with the procedures of this chapter.
- 3. Property may be leased, or a license may be granted, without publication of notice of intent to lease or license, or competitive bidding if the term of the lease or license, including renewals or options to renew, is not more than two years and the amount of the annual rent is not more than five years and the amount of the annual rent is not more than five thousand dollars per year or, where the rent is a percentage of the tenant or licensee's gross revenue, the annual rent is not more than ten percent of the tenant's gross revenue.
- 4. The Common Council shall not lease or license the use of City property for a term in excess of two years, or where the rent is more than five thousand dollars per year or ten percent per year of gross revenue, without publication of intent to lease or license and competitive bidding. Notice of intent to lease or license the use of property shall be published one time in the official newspaper of the City of Plattsburgh not more than 20 nor less than 6 days prior to the date bids are accepted. The notice shall contain a summary description of the proposed terms of the lease or license. Competitive bidding may be by written sealed bid or public auction.
- 5. No lease or license shall be made or granted unless the same is authorized by resolution of the Common Council.
