LOCAL LAW NO. 5 OF 1962

ENTITLED AN ACT CREATING AND ESTABLISHING CERTAIN POSITIONS AND
AMENDING SECTIONS 1 AND 2 OF LOCAL LAW NO. 2 OF 1961 REGARDING
SALARY RATES FOR SALES TAX ATTORNEY, SENIOR TAX EXAMINER,
PRINCIPAL ACCOUNT CLERK, ADMINISTRATIVE ASSISTANT, SALES TAX
EXAMINER AND CITY CHAMBERLAIN.

BE IT ENACTED BY THE MAYOR AND COMMON COUNCIL OF THE CITY OF
PLATTSBURGH, NEW YORK, AS FOLLOWS:

SECTION 1: THE FOLLOWING POSITIONS ARE HEREBY CREATED AND ESTABLISHED
SENIOR TAX EXAMINER, PRINCIPAL ACCOUNT CLERK, ADMINISTRATIVE ASSISTANT
AND SALES TAX EXAMINER IN THE COMPETITIVE CLASS.

SALES TAX ATTORNEY IN THE EXEMPT CLASS.

SECTION 2: (A) SECTION 1 OF LOCAL LAW NO. 2 OF 1961 IS HEREBY AMENDED
BY ADDING THE FOLLOWING:

(B) SECTION 2 OF LOCAL LAW NO. 2 OF 1961 IS HEREBY AMENDED, BY
ADDING THE FOLLOWING:

SENIOR TAX EXAMINER AND PRINCIPAL ACCOUNT CLERK TO GRADE 22
(\$4940-\$5720)

ADMINISTRATIVE ASSISTANT TO GRADE 18 (\$4264-5044)

SALES TAX EXAMINER TO GRADE 15 (\$3952-\$4732).

(C) SECTION 2 OF LOCAL LAW NO. 2 OF 1961 IS HEREBY AMENDED BY
CHANGING THE GRADE OF THE CITY CHAMBERLAIN FROM GRADE 26 TO GRADE 29,
WHICH GRADE 29 IS HEREBY ESTABLISHED AS FOLLOWS:



AFTER PUBLIC HEARING AND APPROVAL BY THE MAYOR.


