

AT A REGULAR MEETING OF THE COMMON COUNCIL OF THE CITY OF PLATTSBURGH, NEW YORK, HELD MAY 5, 1966.

LOCAL LAW NO. 6 OF 1966

A LOCAL LAW CREATING A PARK AND BEAUTIFICATION COMMISSION.

BE IT ENACTED BY THE COMMON COUNCIL OF THE CITY OF PLATTSBURGH, NEW YORK, AS FOLLOWS:

SECTION 1: CREATION OF COMMISSION. THERE IS HEREBY ESTABLISHED IN THE CITY OF PLATTSBURGH, A PARK AND BEAUTIFICATION COMMISSION, CONSISTING OF ELEVEN MEMBERS, EACH OF WHOSE TERM OF OFFICE SHALL BE FOR THREE YEARS, EXCEPT THAT ON FIRST APPOINTMENT FOUR OF SUCH MEMBERS SHALL BE APPOINTED FOR ONE YEAR; FOUR SHALL BE APPOINTED FOR TWO YEARS AND THREE SHALL BE APPOINTED FOR THREE YEARS. SAID TERM OF OFFICE SHALL COMMENCE ON JUNE 1ST OF EACH YEAR, COMMENCING JUNE 1, 1966. THE MEMBERS OF SAID COMMISSION ARE TO BE APPOINTED BY THE MAYOR, SUBJECT TO THE APPROVAL OF THE COMMON COUNCIL.

SECTION 2. DUTIES. THE SAID COMMISSION SHALL ELECT THEIR OWN CHAIRMAN AND SECRETARY, AND SHALL HAVE THE CARE, CONTROL AND CUSTODY OF ALL PARKS WITHIN THE CITY OF PLATTSBURGH, SOUTH OF SCOMOTION CREEK, AND OF ALL GRASS PLOTS AND LAND BETWEEN THE SIDEWALKS AND CURBS OWNED BY THE CITY OF PLATTSBURGH, AND SUCH OTHER LANDS AS MAY BE PLACED UNDER THEIR JURISDICTION BY THE COMMON COUNCIL, AND SHALL BE EMPOWERED TO TAKE ALL STEPS NECESSARY FOR THE BEAUTIFICATION OF THE SAME WITHIN THE LIMITS OF ANY APPROPRIATION MADE BY THE COMMON COUNCIL OF THE CITY OF PLATTSBURGH, AND SHALL ACT IN AN ADVISORY CAPACITY TO THE MAYOR AND COMMON COUNCIL IN ALL MATTERS PERTAINING TO THE BEAUTIFICATION OF THE ENTIRE CITY. THE SUPERINTENDENT OF PUBLIC WORKS SHALL ACT AS SUPERINTENDENT OF PARKS.

SECTION 3. ABOLITION OF CIVIC BEAUTIFICATION COMMISSION. THE CIVIC BEAUTIFICATION COMMISSION OF THE CITY OF PLATTSBURGH IS HEREBY ABOLISHED AS OF MAY 31ST, 1966.


SECTION 4. THIS ACT SHALL TAKE EFFECT AFTER PUBLIC HEARING AND APPROVAL BY THE MAYOR.
