WHEREAS, <u>City of Plattsburgh</u> acknowledges the requirements of Section 322 of DMA 2000 to have an approved Hazard Mitigation Plan as a prerequisite to receiving post-disaster Hazard Mitigation Grant Program funds, and

WHEREAS, <u>City of Plattsburgh</u>, with the assistance from the Clinton County Planning Department and Mountain View Planning, in cooperation with other county departments, local municipal officials and the citizens of Name of Municipality, has gathered information and prepared the Clinton County Pre-Disaster Multi-Jurisdictional Hazard Mitigation Plan; and

WHEREAS, a public involvement process consistent with the requirements of the DMA 2000 was conducted to develop the Clinton County Hazard Mitigation Plan, and

WHEREAS, the Clinton County Pre-Disaster Multi-Jurisdictional Hazard Mitigation Plan has been prepared in accordance with the Disaster Mitigation Act of 2000; and

WHEREAS, The Clinton County Hazard Mitigation Plan recommends mitigation activities that will reduce loss to life and property by both natural and human-made hazards that face the County and its municipalities, now
