WHEREAS, on January 28, 2014, Governor Andrew Cuomo issued Executive Order 125 directive State agencies to conduct a review of safety procedures and emergency response preparedness related to the shipments of volatile crude from the Bakken Oil fields in North Dakota and other sources; and

WHEREAS, the State has formed the New York State Foam Task Force (Task Force), which is a state and local partnership, to support and supplement existing local foam capabilities to assure that trained personnel and the appropriate equipment is available at strategic locations throughout the State based on risk;

WHEREAS, as a result of the review, DHSES has acquired a quantity of foam trailers, equipment and supplies, and pre-positioned such equipment at strategic locations with participating agencies that herein agree to support the efforts of the Task Force;

WHEREAS, this Agreement establishes the responsibilities, guidelines and procedures for the assignment, deployment and use of the equipment to the Participating Agency by DHSES; WHEREAS, the Participating Agency acknowledges receipt of said equipment;

NOW, THEREFORE, in consideration of the promises set forth herein, be it known that a DHSES hereby grants a temporary revocable permit to Participating Agency to use the Equipment designated in Section 3, and the Parties agree to the terms and conditions of agreement. No. DHS01-X200057-1160200. The entire text of which has been distributed to and read by the members of the Common Council, is hereby enacted without the reading thereof and a copy of said agreement is made part of the minutes of this meeting.

NOW, THEREFORE, BE IT RESOLVED, the Common Council authorizes the Mayor to execute an access agreement with NYSEG for soil and groundwater testing, investigations, and work on City property located at 25 Caroline St. for a period to begin on the date of the agreement's execution and to terminate one hundred eighty (180) days after notice, as received, outlined, and determined from NYSDEC, defining the completion of remediation, testing, and monitoring activities on the Premises.

7.164 RESOLUTION: APPROVAL OF THIRD PARTY AIR MONITORING AGREEMENT FOR DEMOLITION OF NORTHERN BEACH BATHHOUSE & OLD BASE MARINA BUILDING

WHEREAS, both the northern bathhouse at the City beach and the old base marina building have been condemned by the City's Building Inspector upon a recognition that both buildings present an imminent public danger to the extent that the buildings are structurally unsound/unsafe and the City is unable to completely prevent public access to the buildings – despite reasonable measures being taken – and the situation requires expeditious action which cannot await public bidding; and

WHEREAS, NYS regulations mandate third party air monitoring for all demolition activities involving structures that have been found to include asbestos containing materials; and

WHEREAS, KAS, Inc. has extensive experience with third party air monitoring during demolition activities and has performed well under previous agreements with the City.

NOW, THEREFORE, BE IT RESOLVED, the Common Council authorizes the Mayor to execute an agreement with KAS, Inc. for third party air monitoring activities required by the demolition of both the northern beach bathhouse and the old base marina building in an amount not to exceed \$6,970.

RESOLUTION 7.165 – 07/01/21

7.165 RESOLUTION: APPROVAL OF DEMOLITION PROPOSALS FOR NORTHERN BEACH BATHHOUSE AND OLD BASE MARINA BUILDING

WHEREAS, on May 21, 2021, the City's Building and Zoning Department issued a letter addressing the current state of both the northern beach bathhouse and the old base marina building that condemned both structures and concluded that, "...the buildings in question are structurally unsound and unsafe."; and

WHEREAS, an imminent public danger is created by the unsafe condition of these structures, their comparatively remote locations, and the practical difficulties involved with ensuring no members of the public can access either building; and

WHEREAS, the City's procurement policy allows for an exception to the prescribed public bidding requirements for public works projects in "emergencies where time is a crucial factor" and this situation requires expeditious action which cannot await public bidding.

NOW, THEREFORE, BE IT RESOLVED, the Common Council authorizes the Mayor to execute two proposals with JEDA Environmental Services for the demolition of the northern beach bathhouse and the old base marina building in a total amount not to exceed \$88,120.

RESOLUTION 7.166 – 07/01/21

7.166 RESOLUTION: APPROVAL OF CONSULTING AGREEMENT WITH MALANA TAMER

WHEREAS, the Community Development Office (CDO) is currently responsible for managing the City's Planning Board and numerous complex projects; and

WHEREAS, Malana Tamer's prior management of the City's Planning Board was exemplary and her knowledge of projects managed by the CDO is unique; and

WHEREAS, the CDO requires assistance with management of both the City's Planning Board and other projects until a more permanent staffing structure can be put in place to manage those responsibilities.

NOW, THEREFORE, BE IT RESOLVED, the Common Council authorizes the Mayor to execute a consulting agreement with Malana Tamer for Planning Board management and other planning services in an amount not to exceed \$7,500.

Now, therefore, be it resolved, that the Common Council authorizes the City Attorney to prepare a short Environmental Assessment Form and further to submit a GML 239-m referral packet to the Clinton County Planning Department for this proposed local law.
