WHEREAS, CDM Smith has provided a September 27, 2023 proposal for performing the final design of these architectural upgrades;

NOW, THEREFORE, BE IT RESOLVED, The Common Council agrees to the proposal and authorizes the execution of all necessary documents to enter into the agreement. Funding will be from Capital Project H8130.68.
