

As per counselor Kelly's request, I would like to give the second of this year's quarterly reports on the contract between the City of Plattsburgh's Police Department and Eagle's Nest Veterinary Hospital. This contract is regarding the housing of dangerous dogs being confined at Eagle's Nest Veterinary Hospital per police department request. The first report was presented verbally during a city council meeting given earlier this year, and is the same as this report.

As of January 1st 2019, the police have not presented any dogs to Eagle's Nest Veterinary Hospital for confinement under the dangerous dog contract and therefore the city has incurred no expenses toward housing dangerous dogs to the present (6/19/19).
