MEMORANDUM OF UNDERSTANDING Amendment 1 (original dated March 1, 2019)

This Memorandum of Understanding, made and entered into this 27th day of August, 2019, by and between the City of Plattsburgh, with its offices at 41 City Hall Place, Plattsburgh, New York 12901, acting by and through its Mayor, Colin Read (hereinafter "City") and the Clinton County Board of Realtors, with its offices at 6 Pond Street, Suite 2, Plattsburgh, New York 12901 acting by and through its Association Executive Michael Coughlin.

WITNESSETH:

Whereas, the City of Plattsburgh owns and maintains municipal parks around the City of Plattsburgh, including the enclosed dog park which is located on the northerly portion of the City Beach property located at 4 Beach Road in the City of Plattsburgh (hereinafter "Dog Park"); and

Whereas, the Clinton County Board of Realtors (hereinafter "Realtors"), which is a local professional association of realtors, has received a national grant to beautify and improve public spaces in the community; and

Whereas, Realtors has identified the Dog Park as a gateway to the City which could benefit from an upgrade and beautification project; and

Whereas, the City and Realtors have participated in several meetings, which have resulted in a request to memorialize this Dog Park improvement project via this Memorandum of Understanding; and

Whereas, the City of Plattsburgh find that this Memorandum of Understanding serves a proper public and municipal purpose.

NOW, THEREFORE, it is mutually agreed as follows:

- 1. Realtors shall provide a detailed sketch plan, drawn reasonably to scale, showing the proposed improvement plan for the Dog Park.
- 2. Components of the proposed improvement plan include:
 - excavation, removal and disposal of 1/3 of the existing concrete pads located on the 1/2 of the Dog Park furthest from the entrance gate as you move towards the beach area
 - installation of sod and/or grass seed in the disturbed area described above, as well as others areas within the enclosed area where needed
 - removal of weeds and shrubs along the fence line and reinforcement of the fence where needed
 - installation of various "dog activity features" (i.e. tire tunnel, ramp) as well as owner benches within the enclosed area
 - installation of wooden flower/planter boxes on various locations on top of the fence
 - design, manufacture, and installation of an outward facing sign describing this dog park as the "City of Plattsburgh City Beach Dog Park—Sponsored by the Clinton County Board of Realtors"
 - possible installation of a dog watering feature and a dog waste disposal unit
- 3. The Realtors shall employ reasonable efforts to ensure that those sections of the Dog Park not under construction are available for use by patrons for the duration of the work.

- 4. The City shall confirm in writings its acceptance of the proposed improvement sketch plan for the Dog Park as submitted by the Realtors prior to any work being performed.
- 5. Realtors shall be responsible for all expenses associated with this proposed improvement plan, including the excavation, hauling and disposal of the removed concrete. In addition, Realtors shall perform monthly maintenance of the Dog Park (not including grass cutting or grass watering) during the months of May through September of each year. The City shall grant a revocable license to any contractor or volunteer associated with the Realtors for purposes of accessing the Dog Park in furtherance of the proposed improvement plan. Any contractor acting as agent for Realtors shall provide a certificate of insurance and also shall agree to indemnify and hold the City harmless for any work performed at the Dog Park. Volunteers performing work for the Realtors shall also agree to indemnify and hold the City harmless for any work performed at the Dog Park. Realtors and their agents shall coordinate with the City's Department of Public Works to obtain a dig safe permit prior to excavation.
- 6. The proposed sign described above shall require written approval by the City prior to installation.
- 7. As noted above, the City will make reasonable efforts to mow the Dog Park, remove trash, and perform basic maintenance as needed.
- 8. The City may require that certain areas of the Dog Park be closed to allow for the grass seed/sod to become established.
- The parties are hereby committed to cooperating with each other and will work in good faith towards the terms defined in this agreement. In an event of a breach of this understanding, the MOU shall be terminated on written notice.

The parties hereto indicate their acceptance of and agreement with the terms of this Memorandum of Understanding.




